 - 2.2 Files are printed as they are delivered. Colour variations will occur when reordering jobs and PosterBox will not supply colour matching. 2.4 PosterBox stores the pdf files of completed orders for 12months. However, PosterBox shall incur no liability whatsoever in the event of data losses. The user shall keep a safe copy of the transferred files. Files are deleted from PosterBox's database 12 months after the processing of the order. Customers will be advised and can request the files not be deleted, this request must be made in writing 14 days prior to the 12 month expiration period.

3 SAME DAY DISPATCH

- 3.1 For orders to be dispatched same day a completed order must be received by 1.00pm EST and be a standard order as defined in clause 1.1. Operating hours are Monday to Friday 8.30am to 5.00pm. Orders received between 5.00pm Friday and 8.30am Monday will be dispatched Monday.
- 3.2 Large Quantities. Orders of 30 posters or more will require more than 24hours production time. On confirmation of such an order PosterBox will inform the customer of the expected delivery date by email within 24 hours.
- 3.3 Canvas is a low stock item therefore orders of 10 or more canvas prints will take up to 5 days to produce.
- 3.4 Same Day dispatch provision is made in good faith, with consideration to the conditions and circumstances that are known to PosterBox at the time.
- 3.5 If PosterBox is unable to deliver the full order due to any cause at all, PosterBox will deliver part of the order. The customer will be notified via email if such an event is expected to occur.
- 3.6 PosterBox guarantees to do its utmost to ensure availability of the services. A temporary interruption of our service is, however, possible for technical reasons. PosterBox will make every effort to inform its customers as efficiently as possible about the nature and duration of any interruptions, but shall incur no liability whatsoever in the event that its services are unavailable. Similarly, PosterBox cannot guarantee the reliability and quality of the Internet outside its own premises.

4 DELVIERY

- 4.1 PosterBox ensures fast and on time dispatch of goods but holds no responsibility for loss or damaged goods once dispatched. Posters are delivered by courier. All consignments can be monitored through the client area which allows the customer to link directly to the couriers tracking system. PosterBox accepts no liability for goods once dispatched. All concerns on delivery of products once dispatched from PosterBox are to be directed to the courier directly.
- 4.2 The Customer will upon delivery, examine the goods and notify PosterBox of any errors or shortages no later than four days after delivery.

5 DEFECTS

- 5.1 Any claim by the Customer relating to any imperfection in print quality of the posters, or any shortage or other nonconformity to an order for goods shall be made in writing to PosterBox at its address: PosterBox, 26 Hobson Dr, Cairns 4870 or email no later than four days after delivery.
- 5.2 Unless such written claim is received by PosterBox within the specified period, the Customer shall be deemed to have accepted the condition of the goods and the consistency of the goods to the order.
- 5.3 Any claim in relation to a defect in goods must be accompanied by a sample poster showing the alleged defect.

6 RETURNS

- 6.1 No goods shall be returned to PosterBox by the Customer without the written consent of PosterBox.
- 6.2 If PosterBox agrees to the return of goods, PosterBox shall not be required to accept such goods by way of return unless:
- The goods are unused and undamaged and in their original packaging; and
 - The goods and the packaging are as new and in a saleable condition.
